Through AWS, agencies receive timely messages from OEM about emergency incidents which are designed for people with special needs. As an AWS member, in addition to receiving real-time emergency notifications and alerts through email, your agency will gain access to the new AWS website, which supports agencies with additional hazard-specific information and planning tools. Advance Warning System Overview

New York City's Office of Emergency Management (OEM) designed the Special Needs Advance Warning System (AWS) to alert individuals to various types of hazards in New York City that may affect their independence and their daily lives. AWS messages are sent out about events like hazardous weather, utility or transportation disruptions, public health emergencies and incidents requiring evacuation. The messages reach people with special needs through their service providers. These agencies have developed trusted relationships with their clients and can tailor the emergency information to support their specific needs. This information helps agencies prepare for potential emergencies and empowers their clients to act in a way that is most appropriate for them.

Advance Warning System Website

OEM and the Department of Health and Mental Hygiene (DOHMH) partnered to expand the reach of the Advance Warning System and developed the AWS website. The website allows AWS partner agencies to receive messages about emergencies and access tools to support their organizational planning. Interested agencies become involved with AWS through website registration. Any New York City agency that provides services to clients with special needs can register and use the AWS website to receive emergency and preparedness information, provide contact information to OEM, and participate in surveys.

Agencies with website membership have the ability to:

- Receive real-time notifications and alerts through e-mail
- Gain access to preparedness and event-specific documents and links
- Self-register and maintain contact information and agency service data for use by OEM, DOHMH and other AWS agencies
- Search a database of other Special Need Providers in New York City to foster relationships with similar providers
- Participate in surveys that help inform planning and response efforts for your agency and the populations you serve
